Ann Richards



The night Ann Richards gave the keynote address at the Democratic National Convention, a reporter stepped up to her father and asked, "Well, Mr. Willis, when you told your daughter that she could be anything she wanted to be if she just worked hard enough, did you ever dream that she would be doing something like this?"

Mr. Willis looked the reporter up and down for a minute and then said, "Why, hell, I didn't even know there was a this!"

Throughout a distinguished career, Ann Richards has been opening eyes about the possibility for women in American public life. She began as a junior high school teacher which Richards still says is the hardest work she's ever done, later served on the local planning and zoning commission, helped elect the first female representative, the first Black and the first Hispanic from her home county, and then defeated a three-term incumbent to win a seat on the County Commissioners Court - where she was the first woman to serve as Commissioner in the county's 136 year history. Subsequently, she was elected Texas State Treasurer, becoming the first woman to win statewide office in Texas in half a century. Having won reelection without opposition, she left the Treasurer's post to run for Governor.

On January 15, 1991 Richards became the 45th Governor of Texas - the first woman elected to that job in her own right.

After leaving the Governor's office, Richards worked with a Washington law firm as an advisor, taught a popular course at Brandeis University, and expanded an already busy speaking schedule.

Ann Richards now works with Public Strategies, Inc., an Austin based consulting firm that helps companies analyze, develop and implement their public agendas. At Public Strategies, Richards is a Senior Advisor with special responsibilities for the New York office.

She is a member of several boards including Brandeis University, JCPenney, the Aspen Institute, and Save the Children Federation.

She continues to travel the country speaking out about issues of concern to her.

And, she makes time for her family, which now includes four grown children and seven "nearly perfect grandchildren" - who are all taught that they can be anything they want to be if they will just work hard enough.

Ann is known for speaking out for women's issues and admonishing women to assume leadership roles in every arena. She will provide participants of this year's conference with a dynamic keynote address.

Session Descriptions

Mission: Being an Extraordinary Professional

Today's professionals are under incredible pressure to respond to change, remain proactive and perform under stress. The "stars" at work have something that sets them apart and lets them capture the limelight. We now know the secrets of star performance and how some professionals seem to keep their cool under very demanding circumstances. This keynote is designed to help you master those everyday moments that can lead to success or failure . . . decisions that set the course of your life. This fun and informative session will have you laughing about work – and thinking about different choices you may want to make. Being extraordinary isn't that tough. *(CPE – 2 Hours Personal Development)*

Investing in an Uncertain Market

The year 2002 is shaping up to be a year of the unexpected. We've seen several large declines and smaller rallies in the market, and are now facing an indefinite period of unprecedented uncertainty at home and abroad following the events of Sept. 11. This course will get back to basics and find out how investors can examine and adjust investment goals and expectations. While the current economic conditions warrant concern, most are optimistic about the future, especially about the positive impact of increasing globalization. *(CPE – 2 Hours Consulting Services)*

Trends in HR: Outsourcing

The companies that will continue to succeed in a volatile economic environment will be those that most effectively manage their most critical resource - their employees. Studies show that most executives of medium sized companies intuitively grasp this concept, but have a hard time finding the time and resources to internally develop effective employee administration capabilities within their organizations. This session will demonstrate how outsourcing will reduce the complexity of employee administration and can provide solutions customized to individual requirements and business culture. *(CPE – 1 Hour Management)*

Social Security: Planning For Your Future

This session will be conducted by the Social Security Administration and will provide a brief history of the program, explain the importance of Social Security, who can receive benefits and eligibility requirements, taxation of benefits, the future of the program, and Social Security as it relates to financial planning. There will be time for questions and answers and resource information will be provided. *(CPE – 1 Hour Accounting & Auditing)*

Smart Women/Smart Lives

Where have all the smart women gone? This exciting and dynamic presentation about women and achievement is based on Alice Rowe, Ph.D.'s book by the same title, which grew out of her doctoral study of American women. Ms. Rowe will take her audience to "A Country Called Double Blind," which concerns how women feel pushed and pulled in conflicting directions. There are four lands in this Country: Lost Dreams, Sexism, Dumbing Down, and No Cracks Allowed. They next "travel" to "a Country Called Celebration." She will tell of inspiring models of achievement and of triumphs in the midst of conflicting expectations. *(CPE – 1 Hour Personal Development)*

Expanding Exposures Being Faced by Practicing CPAs

The AWSCPA will bring participants the most innovative and cutting edge information regarding expanding exposures to risk. This course will be an informative presentation on how to develop a loss prevention program while enhancing the firm's expertise and skills of their staff. *(CPE – 1 Hour Accounting & Auditing)*

Work Styles: So That's Why You Drive Me Crazy!

Often we hear people say, "He's so hard for me to work with," or "if we work on a project together, we seem to rub each other the wrong way." Usually the conclusion is that there are personality differences. But, it often is not that at all – it's work style differences. Some of us are detail folks. Some are not. Some of us like a lot of action and activity. Some of us like a calm and reflective approach. Neither approach is wrong – they are just different. The main objective of this workshop is to understand that we indeed have different work styles. Instead of letting them drive us crazy, we need to learn how to work best with them. Another key objective is to identify your strongest work style, using a simple exercise, which can easily be taken back to work and used to help other staff members understand one another and identify ways to work better together. *(CPE – 1 Hour Management)*

SEC Update

Find out about the most recent changes in the world of securities directly from the SEC. In the rapidly changing business and economic environment, it's critical to be aware of what the SEC is doing. A representative from the U.S. Securities and Exchange Commission will describe in detail how the world of investing continues to be fascinating, complex, and can be very fruitful. *(CPE – 1 Hour Accounting & Auditing)*

The AICPA's Work/Life and Women's Initiatives Executive Committee Update and Roundtable Discussions

In the spring of 1992, the AICPA's governing council created the Work/Life and Women's Initiatives Executive Committee (WLWIEC), reporting directly to the AICPA Board. This committee replaced the former Upward Mobility of Women Committee and exists to help the profession be more effective in addressing the career advancement of female CPAs and family issues in the workplace. The conference will provide a committee update as well as a roundtable discussion on the WLWIEC. *(CPE – 1 Hour Management)*

Retirement Planning: How Much Will I Need?

Will you and/or your clients have enough money to maintain your current lifestyle? Knowing the answer to that question can ease worries and allow individuals to truly enjoy retirement. This course will explain a series of questions and how to formulate answers that will better financially prepare clients for retirement. *(CPE – 1 Hour Consulting Services)*

Corporate Governance

This course will get to the bottom of 'accounting irregularities', in other words, financial fraud. It will explain the corporate environment that causes it, how it spreads, the kind of crises it can create for a company, and the best ways to deal with them. *(CPE – 1 Hour Accounting & Auditing)*

Getting Yourself Back Together and Ready for the Next Deadline

This session will be led by a nurse practitioner, psychotherapist and theologian and will provide a unique perspective to healing and taking care of yourself. Too many times professionals work hard to meet a deadline but never take the time to re-energize before the next hurdle. *(CPE - 2 Hours Personal Development)*

Networking for Success

Through discussion and practical exercises, participants will discuss how to approach a networking opportunity, and get the maximum benefits from time invested. Participants will discuss: Planning your networking approach; the 30-second introduction; making a connection; and following up for ultimate success. *(CPE – 1 Hour Personal Development)*

Economic Update

An economist with the Federal Reserve Bank will discuss the outlook for the nation and how local and national outlooks interact. The presentation's focus will be on how

the various sectors of the economy relate to each other and how deviations from the expected path of one segment of the economy will subsequently impact the overall and regional outlook. *(CPE – 1 Hour Accounting & Auditing)*

How Estates are Taxed and Consequences of Poor Planning

Accountants are often called upon to assist in areas where they do not specialize because they still end up being the most qualified person to organize the details even if they know nothing about the subject. This is especially true when a family member dies. This session will use two actual tax returns to demonstrate the basics of how estate and inheritance taxes are calculated and the importance of basic estate planning even in non-taxable estates. *(CPE – 1 Hour Taxation)*

Business Valuations: Valuing Goodwill and Intangible Assets

This course will outline FASB's new rules that change the way companies must report the value of goodwill and certain intangible assets on their financial statements: SFAS 141 (governing accounting for mergers and acquisitions) and 142 (governing accounting for intangible assets). This course is a must see for all CPAs and financial professionals. *(CPE – 1 Hour Accounting & Auditing)*

Estates and Wills

This session discuss how estates and wills are handled and the relationship developed between accountants and lawyers. There are options in establishing a will that participants should be aware of along with research that should be done. How these options are chosen and how the research is conducted can have a profound effect on the estate. *(CPE – 1 Hour Consulting Services)*

GAAP Update

This session will provide participants with vital information on GAAP and the issues that surround the principles. In this ever-changing profession, it is difficult to keep all professionals up-to-speed, but with this informative update participants will depart the conference one step ahead of their competition. *(CPE – 1 Hour Accounting & Auditing)*

Delegation Skills

This course explores the art of delegating effectively and identifies the skills necessary to be effective as a manager in the accounting profession. The objectives are to define delegation, what it is, what hinders delegation and how to assign tasks and responsibilities to others; to learn the essential management skills of delegation; and to apply coaching principles to ensure success. *(CPE – 1 Hour Management)*

Tax Court Litigation: Strategies, Tips and Tidbits

This course will examine the strategic decision on whether to proceed with a controversial matter to IRS Appeals or directly to court, and will discuss what to expect in a Tax Court trial, highlighting the CPA's role in such a Tax Court controversy. The course will also examine issues of privilege and work-product privilege. *(CPE – 1 Hour Taxation)*

Mentoring Relationships

The course examines the mentoring relationship from the perspective of the mentor, the mentoree and the organization. The objectives are to define mentoring; to explore the steps to creating a relationship; to identify the career enhancement opportunities; to learn how to promote oneself; and to discuss the complexities of cross-gender mentoring. *(CPE – 1 Hour Personal Development)*

Tax Update

Whether you are a tax expert or have your own tax accountant, you need to know what's new and what's proposed in the ever-changing world of taxation. This session will fill you in on changes from both corporate and individual perspectives and will specifically address amendment due to retroactive issues. *(CPE – 1 Hour Taxation)*

Fiesta in San Antonio

San Antonio is a great city with many cultures and a proud heritage. A city made up of many cultures brought here by the 5 military installations as well as the native Latino culture. San Antonio offers many selections of restaurants, museums and entertainment.

San Antonio the ninth largest city in the U.S. - with all the progressive attitudes you'd expect. Including a long and enthusiastic commitment to the

hospitality industry. Yet they hold firmly onto three hundred years of

history and

culture, which began when San Antonio was part of the 18th century Colonial Spain. The result? A city that is turned toward the future. Without turning its back on a rich and vibrant past.

San Antonio is a modern city whose heritage, culture, traditions and natural beauty combine into a unique blend that has attracted adventurers, entrepreneurs, visitors and businesses for hundreds of years. From the earliest Spanish missionaries in 1691 to today's corporate executives and visiting families, its appeal continues to draw attention.

San Antonio was founded as a military garrison in 1718 by the viceroy of Spain, who desired a halfway post between East Texas missions and the Spanish Presidio of Northern Mexico. Several missions were established and for a time prospered and expanded. Settlers from the Canary Islands arrived in 1731 and established a civil government. The missions declined following secularization in 1793 and the waning of Spanish religious and political influence. Major battles were fought here during Mexico's struggle for independence from Spain. From 1821-1836, under a

colonization program carried out by Stephen F. Austin, many Anglo-Americans immigrated to Texas.

However, resentment against the Mexican government grew and in December of 1835, Ben Milam and a small army took the city from the Mexican Gen. Martin Perfecto de Cos. In February of the following year, Gen. Santa Anna, with several thousand troops, marched on San Antonio. After

a 13-day siege, Gen. Santa Anna defeated Col.

Travis and his small army at the Alamo. However, Gen. Santa Anna was defeated a month later at San Jacinto by the army of Gen. Sam Houston. Texas then became the Republic of Texas. In 1845, Texas joined the U.S. as the 28th state.

Residents of San Antonio are some of the world's best 'recyclers.' If a historic building can be reused, developers find the means to turn it into a functional and attractive building. This is evident in places like La Villita, the site of one of San Antonio's original settlements, which now is a collection of artists' workshops, restaurants and historic homes. The River Walk is the city's most popular attraction, changed from an unattractive, flood-prone waterway in the 1920's to a tree-shaded community of restaurants, hotels, cafes, shops and art galleries.

The geographic appeal has spawned a wealth of attractions. The city's warm, sunny climate provides a great environment for year-round golf and tennis. The area's hills and rivers are great spots for hiking and water sports. For more sedate adventures, enjoy the city's museums, symphony perfor-

mances and public gardens.

At the drop of a hat, San Antonians are ready for a party, from a mud festival in January to the city's largest fiesta in April or celebrating Diez y Seis, Mexico's independence day, in September. During other holidays you can enjoy river parades, carnivals and samplings of tasty regional treats. Or catch some exciting action with the city's professional basketball, baseball and ice hockey teams.

Once you arrive in the city, the warmth you will feel is not just the sunny climate but the hearts of its residents. Proud of their city and heritage, they are always ready with the special brand of hospitality for which Texas is so famous.

As the saying goes, "everything is bigger in Texas," and shopping in San Antonio is no exception! The ninth largest city in the United States, San Antonio offers an abundant variety of shops, galleries and malls containing collectibles and clothing as unique and diverse as the Texas landscape. From fine art to Western wear to spicy salsas, you can be sure no shopping list will be left incomplete.

The Alamo has more than 2.5 million people a year visit. The 4.2 acre complex known worldwide as "The Alamo" is where people come to see the old mission where a small band of Texans held out for thirteen days against the centralist army of General Antonio Lopez de Santa Anna. Although the Alamo fell in the early morning hours of March 6, 1836, the death of the Alamo Defenders has come to symbolize courage and sacrifice for the cause of Liberty.

The Guadalupe Cultural Arts Center (GCAC) was founded in 1980 as a non-profit, multi-disciplinary organization whose mission is to preserve, promote and develop the arts and culture of the Chicano/Latino/ Native American peoples. Each year the Center presents and produces a season of events, exhibitions and festivals.

The House is located on a bend of river, at the foot of King William, one of the oldest historic districts in Texas. Carl Hilmer Guenther founder of Pioneer Flour Mills, built this elegant home in 1960. The restored house offers a museum where mill memorabilia is displayed. Of interest to collectors are the Dresden china anniversary plates made in Germany until WWII.

America's Original Kiddie Park, as verified by the National Amusement Park Historical Association sits in San Antonio. Established in 1925, a highlight of any visit to Kiddie Park is the 1918 Herschell-Spillman Carousel featuring 36 jumping horses and two Chariots.

In the heart of this great city, visitors will also find the San Antonio Missions National Historical Park, a cultural oasis.

Transportation

San Antonio International Airport is 13 miles from the downtown River Walk and is linked via IH-37. No matter where you are coming from, you'll find that San Antonio is easily accessible. They are centrally located in the southwestern United States, with air service by both domestic and international major air carriers, as well as many regional carriers.

The airport is less than 15 minutes by car from downtown, even during peak drive times.

Ground transportation

Shuttles and taxicabs depart regularly from the ground transportation level of San Antonio International Airport. A customer service attendant is stationed curbside each day, 6:30 a.m. to 11:00 p.m., to provide assistance with any type of ground transportation. Santrans provides service to the Adams Mark Hotel for \$8 per person one-way or \$14 roundtrip. Taxicabs run continuously. The fare to the hotel will be \$13-\$15 one way. Car rental is also available on the ground transportation level.

Downtown travel is a breeze on the VIA Streetcar, an open air, authentic reproduction of a rail streetcar which traveled the streets of San Antonio more than 50 years ago. Five streetcar

routes to downtown locations are available, including the Alamo, Spanish Governor's Palace, La Villita, Market Square, Sunset Station, Southwest School of Art and Craft, University of Texas, Institute of Texan Cultures at San Antonio, the King William area, downtown shopping and south town areas. Convenient access to all routes from the downtown streetcar station on Convention Plaza. Fare is 50 cents.
