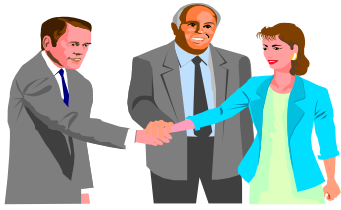
101 for CPA's for the "American Recovery & Reinvestment Act of 2009"

Segment Overview:

The American Recovery and Reinvestment Act of 2009 (ARRA) was passed to provide a stimulus to the US economy in the wake of the economic apocalypse caused by the subprime mortgage crisis and resulting credit crunch. The presentation will include a list of the the important tax cuts (pain relievers) for individuals and businesses as well as a list of other important measures relating to the expansion of domestic spending in education, healthcare, and infrastructure and social welfare programs (subsidies).
