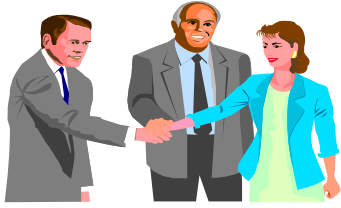
**Shane Landers, ADP Small Business Services
