Jim Small, CPA, MBA

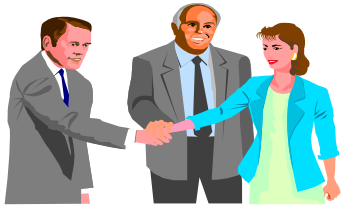
Ethical Dilemmas – What Would YOU Do? – We are often faced with situations in our business careers in which we must choose one of two or more unsatisfactory alternatives.
