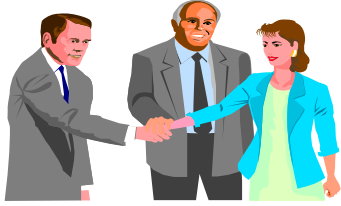
*Martha Moran Schultz, Planner III with the City of Tulsa Planning
