- Must be an Undergraduate Student.
- Must have a cumulative B average by application deadline.
- Must be an Accounting Major and plan on pursuing a career as a CPA.
- Must provide a validated full transcript from a college or university in New Jersey.
- Must complete an essay no longer than 1,000 words on topic provided.
- Involvement in school, community, professional and/or charitable organizations is desirable.
- Applications must be received on or before April 30, 2011.
