The AWSCPA will recognize the individual achievements of its members with the following awards in 2009-2010. The awards will be presented at the AWSCPA National Conference in Nashville in the fall of 2010.

## *The AWSCPA CPA of the Year Award*

The **Woman CPA of the Year Award** was established to recognize an individual for outstanding contributions to the accounting profession. Criteria for this award will be professional accomplishments, demonstrated leadership, and contributions, which further the advancement of women in the profession. Such contributions may include but are not limited to participating in successful mentoring relationships, implementing flexible work schedules or other family-friendly arrangements, advocating programs that promote women with a company, and supporting diversity programs. Nominations should include background information on the nominee and the reason why she should be selected. Self-nominations are welcome.

## *The AWSCPA Educator of the Year Award*

The **Educator of the Year Award** continues to recognize excellence in teaching in the accounting field by a faculty member of a two- or four-year college. Self-nominations are welcome.

## *The AWSCPA Public Service Award*

The **Public Service Award** recognizes a member who provides a significant contribution of time and talent to public services outside of the accounting profession. Self-nominations are welcome.

## *The AWSCPA Woman of Courage Award*

The **Woman of Courage Award** recognizes member achievement under difficult conditions.
